PRIOR TO NATIONWIDE QUARANTINES, CAMP HENDON HOSTED A TEEN RETREAT WEEKEND FOR 20 CAMPERS, AGES 13-17. THE CAMP AWARDED 1 PARTIAL CAMPSHIP TO 1 CAMPER AND 1 OTHER CAMPER RECEIVED A FULL CAMPSHIP. CAMP HENDON HOSTED ONE PARENTS NIGHT OUT FOR 25 CHILDREN, AND ONE FREE FAMILY EVENT FOR 87 ATTENDEES. IN-PERSON MEDICAL SUMMER CAMPS SHIFTED TO TWO WEEKS OF VIRTUAL PROGRAMMING. A TOTAL OF 106 CAMPERS, AGES 7-17, REGSITERED FOR "CAMP HENDON AT HOME". ALONG WITH VIRTUAL PROGRAMMING, "CAMP IN A BOX" WAS DISTRIBUTED TO ALL REGISTERED CAMPERS.
