THE CAMP SERVED 142 CAMPERS THIS YEAR, 3 CAMPERS WERE NON-DIABETIC CHILDREN OF STAFF, 1 CAMPER A NON-DIABETIC SISTER OF CAMPER AND 138 CAMPERS WERE "T1D CLUB MEMBERS." 36 CAMPERS WERE ABLE TO ATTEND WITH 100% OF THE EXPENSE PAID BY CAMP HENDON. THE CAMP ALSO AWARDED 22 PARTIAL CAMPERSHIPS. THE TOTAL VALUE OF DONATED DIABETIC SUPPLIES AND MATERIALS USED DURING CAMP WAS \$231,000. THE TOTAL VALUE OF TIME DONATED TO CAMP BY VOLUNTEERS DURING THE FISCAL YEAR WAS \$493,918.
